# 2024 Annual Resort Pass Program

## ACCESS

- Hot Pools
  - Adult Swim 7am-8am
  - Open Swim 8am-9pm
- Fitness Center
- Sports Court
- 15% Lodging Discount
  - Lodging must be booked and paid for by the annual pass holder.
- Invitation to Annual Celebration Event
- Priority Renewal Status
  - Pass holders from 2023 will have the first opportunity to re-purchase their annual pass for 2024. Passes are open to other purchases on January 1, 2024. Limited annual passes will be sold.
- Guest Day Passes (10) Included
  - Valid for single access.
  - Must be accompanied by Primary Pass Holder and pass must be turned into Front Desk upon entry.
- Additional Guest Day Passes
  - Available for purchase at the front desk based upon resort occupancy for \$20 fee/pass.



### INFORMATION & PRICING

- A limited quota of Annual Resort Passes will be offered each year, so you are encouraged to apply early.
- Application process for 2024 begins November 17, 2023.
- Pass is good from 1/1/2024-12/31/2024.
  - There will be no prorated rates for approved applications received after 1/1/2024.
- **PASS IS REQUIRED FOR ENTRY AT ALL TIMES.** We encourage you to take a picture on your phone, so that you always have your pass. NO PASS, NO ENTRY.
- Annual Pass purchases requires a code of conduct signature from all pass holders over the age of 18.
  - Primary pass holder will be liable for all child/dependent passholders.
- Applications will be reviewed by the owners and management team for approval.
- Expect a response within 5-10 business days regarding your application.
- Once the Annual Resort Pass application is approved, a current photo of all pass holders will be processed, and pass will be issued within 5-10 days.
- Full payment must be made at time of Pass Purchase and is non-refundable and not transferable.
- Any violation of Saratoga Hot Springs policies or code of conduct will result in immediate revoking of the annual pass with NO REFUND.

# SARATOGA HOT SPRINGS RESORT 2024 ANNUAL RESORT PASS CODE OF CONDUCT

Annual Pass purchases requires a code of conduct signature from all pass holders.

The primary adult pass holder is responsible for the actions of all additional pass holders (adult partner and children).

It is expected that professional behavior and cooperation occurs with other passholders, resort lodging guests and resort employees.

All Saratoga Hot Springs Resort Annual Pass holders at the Saratoga Hot Springs Resort are expected to conduct themselves in a manner that:

- *Is free of discrimination or any form of harassing behavior to resort guests, staff, and other pass holders.*
- *Acknowledges the Saratoga Hot Springs Resort facilities as a customer and family friendly environment and refrains from using obscenities, excessively loud or otherwise inappropriate behavior.*
- *Observes that we allow no music, coolers, smoking, or inflatables in the pool area. (pool noodles are allowed)*
- *Shows the utmost respect and dignity to all visitors and staff.*
- *Demonstrates an understanding that visitors have no authority to instruct staff in job performance and duties.*
- *Is vigilant in reporting real or perceived safety hazards to staff or management.*
- *Does not misrepresent their position or authority to others.*
- *Follow all posted rules and regulations while enjoying our pools.*
- *Complies with all Saratoga Hot Springs Resort staff requests.*
- *Does not interfere with the ability of customers and/or staff to use the pools for its intended purpose.*
- *Acknowledges that only alcoholic beverages purchased at the Saratoga Hot Springs Resort, Snowy Mountain Brewery, and/or Wyoming Outdoor Adventures are permitted on the premises.*
- *Acknowledges the Saratoga Hot Springs Resort does not have a lifeguard on duty. Please swim at your own risk.*
- *Absolutely no glass in the pool area!*
- *All guests are required to check in at the front desk and follow pool area hours-Adult swim is from 7AM-8AM- Open swim is from 8AM-9PM.*
- *No children under the age of 16 are allowed on premises unless accompanied by an adult passholder.*
- *Primary pass holder is liable for partner and child pass holders.*
- *No children are allowed in the TeePee pools.*

Any customer or visitor who violates or fails to observe the Saratoga Hot Springs Resort Code of Conduct may be sanctioned as follows:

- *Issuance of a verbal warning*
- *Issuance of a written warning*
- *Suspension of his/her pool privileges for a defined period*
- *Revocation of his/her Hot Spring Pass without monetary reimbursement*
- *Removal from the facility*
- *Monetary restitution for damage to property*
- *Forfeiture of all fees paid*

## PHOTO REQUIREMENTS FOR ANNUAL PASS



*Photo should be a clear, front view of passholder's face.*

*Head needs to be centered and take up majority of the photo.*



*No hats, sunglasses, goggles, helmets, or objects obstructing your face.*

*All passholders need to submit a RECENT, updated photo for their personal pass.*



*Photos that do not meet the requirements will be rejected, further delaying printing of the Annual Resort Pass and delaying access provided.*

# 2024 Saratoga Public Golf Course Rates

## **Respect the Course**

- ❖ Repair all ball marks on greens.
- ❖ Replace or repair all divots.
  - ❖ Rake all bunkers.

Sand/Seed Mixture provided on carts.

## Saratoga Public Golf Course Rules & Regulations

- Tee Times are Mandatory (307)326-5153
- Cancellations shall be made 24 hours in advance.
- Cancellations received within the 24-hour period will be charged depending on the resale of that tee time.
- Golfers need to check in at Wyoming Outdoor Adventures prior to playing and are to have a dated valid greens fee or greens fee w/cart receipt in their possession at all times while on the golf course.
- Must be 18 with a valid driver's license to rent a cart.
- Carts and rental equipment are to be used on the Saratoga Hot Springs Resort Property only.
- 2 persons per cart MAX.
- Don't drive carts through standing water or areas marked off.
- Keep all electric carts 30 ft. from greens and tees.
- Appropriate golf attire must be worn at all times.
- Each player must be registered at the golf shop and have a set of clubs.
- Soft spikes or athletic shoes required.
- All play is to begin on the #1 tee unless instructed otherwise by Saratoga Hot Springs Resort/Wyoming Outdoor Adventure personnel.
- Play USGA rules unless modified by local rules.
- Pace of Play is
  - 9 holes: 2 hours, 10 Min
  - 18 holes: 4 hours, 20 min.
- Let faster golfers play through when hole ahead is open.
- Additional cart fees apply for non-playing spectators.
- Large groups (12 or more) wanting a multiple hole start will be required to let golfers play through or will need to reserve entire course.
- No outside alcohol is permitted on the property.
- Must be 21+ to purchase alcoholic beverages.
- Do not open or consume beverages until on golf course grounds and dispose of any opened containers prior to leaving course.
- Drop away from and protect all banded trees.
- Twilight golfers are not guaranteed to complete 18 holes prior to course closure.
- Players are expected to continue to play during rain and/or drizzle.
- All players requesting a rain check may be required to wait up to an hour after check-in to determine if course conditions will improve. A rain check may only be issued if management deems the course unplayable.
- Rain checks are good for 30 days and are non-transferable, non-replaceable, and hold no cash value.
- Frost Delay Policy-following the delay, tee times will go at scheduled times. Groups that are not present at the appointed time become standby players only.
- All rates are subject to change.

## PUNCH CARD PROGRAM

- ❖ Punch cards must be redeemed for every round/re-round at scheduled tee time.
- ❖ Punch cards are separate than Annual Resort Passes.
- ❖ Anyone can purchase punch cards, and there is no limit to number of punch cards issued.
- ❖ Punch card is transferrable.

**Saratoga Hot Springs Resort 2024 Annual Pass Holder Assumption of Risk**

The primary passholder hereby acknowledges and agrees that the use of the Saratoga Hot Springs Resort facilities and any privilege or services to pass holders is undertaken with knowledge of risk of possible injury. Primary passholder accepts any and all risk of injury, whether the injury is sustained by himself or herself, his or her partner, his or her family members and/or his or her guests while using the Resort Facilities or involved in any event or activity incident to pass holder access to the Saratoga Hot Springs Resort. In accepting the risk of injury, the pass holder understands that he or she is expressly relieving INTERNATIONAL RESORT PROPERTIES, LLC, a Colorado limited liability company, doing business as Saratoga Hot Springs Resort, it's respective owners, annual pass holders, stockholders, predecessors, successors, assigns, agents, directors, officers, employees, former employees, representatives, attorneys, affiliates (and all agents, directors, officers, employees, representatives or attorneys of such affiliates), and all persons acting by, though, under or in concert with Saratoga Hot Springs Resort, from any and all grievances, charges, complaints, claims, damages, actions, causes of action, suits, rights, demands, costs, losses, debts and expenses, including attorneys' fees, statutory penalties and/or costs incurred (collectively, "Claims"), of any kind, nature or character whatsoever, known or unknown, at law or in equity, which he/she now has, owns or holds, claims to own or hold, at any time heretofore had, owned or held, or which he/she may in the future have, own or hold, arising under or in any way related to use of the sport court, hot springs, golf course and any other amenities located at, used in connection with or provided by the Saratoga Hot Springs Resort.

Pass holder agrees to indemnify and hold Saratoga Hot Springs Resort harmless from any and all liability, costs or expenses, including, without limitation, costs and attorneys' fees incurred or which may be incurred by pass holder, his/her partner, children, family member and any of their guests in the event of any Claims asserted in contravention to this assumption of risk or by any other person, party, or entity claiming by, through or under pass holder. It is the specific intent and purpose of this Assumption of Risk to release and discharge any and all claims and causes of action, whether known or unknown, whether specifically mentioned herein or not, and whether suspected or unsuspected, which might be claimed to exist or arise prior to or after the date hereof, and the undersigned specifically waives any claim or right to assert that any cause of action or alleged cause of action or claim or demand has, through oversight, inadvertence, or error, been omitted from this Assumption of Risk.

I, the undersigned pass holder applicant, hereby acknowledges receipt of the Saratoga Hot Springs Resort Annual Pass documents with rules and regulations and that I have read and understand them and agree to be bound by the terms and conditions thereof as the same may be amended from time to time by the Resort. I further acknowledge that I have read all rules and regulations regarding the Resort's recreational facilities and shall abide by all. I also understand that if any of the rules and regulations are violated by my guest(s), family member(s), or me, the Resort reserves the right to ask the guests(s), family member(s), or me to leave the property, revoke annual pass and even file criminal charges if necessary.
